

Terms and Conditions

1. General Check-in / Check-out Policy is as per below (this may vary for certain hotels):
 - a) General Check-in time is 12 noon and check-out time is 11:00 am
 - b) Subject to availability, early check-in and late check-out will be considered. Charges as applicable
